DETAILS OF ADDENDUM:

1. Question – Are Autocad drawings available?

Answer: AutoCad drawings are not available. All available relevant drawings were included in the original RFP along with the option to visit the site.

2. Question – What is the address of the site?

Answer: The address, as provided in Section 3.3, is 700 Railway Ave, Canmore, AB.

3. Question – Are care and maintenance data a required deliverable?

Answer: Yes, for the project close out but not at the time of tender.

4. Question – What is available for a laydown area?

Answer: There is room outside the Construction access doors, see drawing A1.2 in the original RFP. Additional laydown areas would include the Elevation Place parking lot west of the building, or on the greenspace at the project NE corner of the Elevation Place site as indicated in drawing A1.2.

NOTE: The Town of Canmore will arrange for the necessary permit(s) for vehicle access on the pathway parallel to the CPR tracks and Railway Avenue. No vehicle traffic is allowed prior to this permit. A flag person will be required in front and behind any moving vehicles while travelling along the pathways.

5. Question – It appears the mats at the base of the stairs are less than 12".

Answer: Correct. To avoid a trip hazard, the first two-foot strip of mat at the base of the stairs is built to 8" to be flush with the first step. We would need this maintained in the new design.

6. Question – The mat appears to be thinner in the novice climbing area by the windows?

Answer: Correct. Due to ventilation grilles, the first one foot of mat along the east wall in the Novice Climbing area is only 7" so as not to block the grilles.

7. Question – Is it acceptable to have the corners of four separate mats connecting in one location?

Answer: The Town prefers that the corners of four mats not come together in one location as the mats can compress and increase the potential for injury. This said, proponents are encouraged to propose new information and technology that may dispel the Town's concerns in this regard.

8. Question – Do you have a preference to how the removable mat sections are lifted?

Answer: The current mats are lifted manually. Proponents are encouraged to include recommendations such as built in lifting straps attached to the bottom of the removable sections, or other, that would make lifting the mats easier and quicker without reducing the safety of effectiveness of the climbing mat system.

9. Question – Have you considered donating the existing mats vs disposal?

Answer: The Town of Canmore is interested in reducing the volume of materials sent to landfill. As requested in section 4.2E1, the Town encourages each proponent to divert waste from landfills and tell us how they intend to do so.

10. Question - Can you send photos of the Climbing Gym when it is not as busy?

Answer: Please see the photos attached.

11. Question – Would it be possible to attend site again during the tender period?

Answer: The Town is willing to accommodate other site visit(s) to assist proponents in submitting a qualified bid. Please coordinate with the Town representative as mentioned in Section 1.1.3 of the original RFP.



